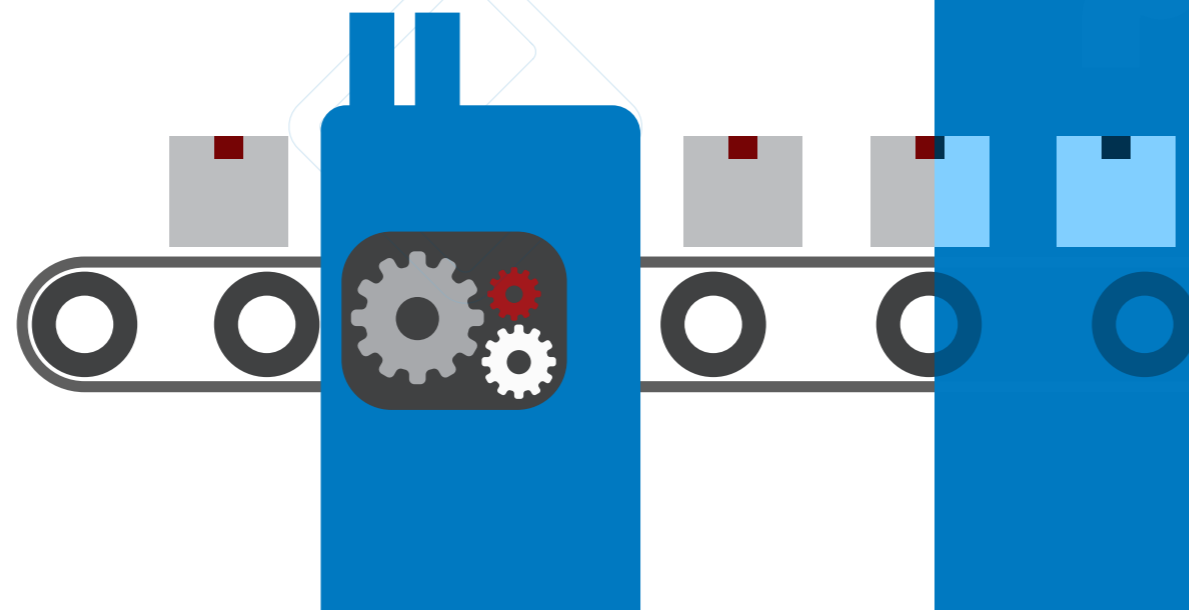

Currently, having 6 registered beneficial models, 2 industrial designs and 1 patent, our Company also awaits evaluation results for its 23 patent applications 9 of which was realized in 2014.

Established with an investment of 180 million dollars in the first stage, the factory now has an annual production capacity of 215 thousand units.

Hyundai Assan Izmit Factory carries a great importance as Hyundai Motor Company's gateway to Europe with its model i10 of A segment and i20 of B segment that are manufactured for Turkey and European countries with the effort of Turkish employees and exported to all region. To date, having manufactured over 1 million vehicles, Hyundai Assan Factory manufactures around 36 vehicles with a daily production of 500 units. i10 and i20s carry the highest level of production quality just like global production centers as manufactured in Hyundai Assan Factory where ISO 9001 Quality Management System and ISO 14001 Environmental Management System are applied.

Annual production capacity of Hyundai Assan Izmit Factory was increased up to 200 units with a new investment established with a ceremony in May 2012. Hyundai Assan included the i10 model into its production line with this 382 million dollar investment as of the end of 2013. Started production on September 26, 2013

and imported to all over Europe and adding value to our country, the new model granted Hyundai with leadership in A segment in a short time. As of November 2014, the second generation i20 began to be produced and achieved in acquiring a significant place in Turkish automotive market quickly. Hyundai with these investments has created an additional employment for about 750 people in the factory. Thanks to this investment reaching up to 650 million dollars together with subcontracting manufacturers, job opportunities have been created for 2,700 people in the region and therefore, Hyundai Assan Factory has become an important center with its manufacturing of A and B segment cars.

Relying on its quality and products, Hyundai holds the quality of becoming the first brand offering "5 Year Manufacturer Company Mechanical Guarantee" for all vehicles in Turkey. Manufacturing packaging solutions for all processed food, candy, chocolate, milk and milk products, pharmaceuticals, cosmetics, cigarettes, beverages, appliances, insulation industries, İSPAK is proud to serve many leading companies of our country and the world, and continues to realize many "firsts" in its sector.

Our R&D team, aiming at developing innovative packaging solutions towards adding value to customer needs and expectations, offers alternatives that will strengthen competition power of our customers that will be suitable for optimal shelf life and food safety requirements, and that will provide ease of use.

As a requisite for serving to the food industry, the studies have been commenced for acquiring "TPM Continuity Award" as the next step of TPM process in our company aiming at development with applications of ISO 9001: 2008 quality system, ISO 22000, OHSAS ISO 18001 and BRC IOP.

İSPAK is able to apply rotogravure up to 10 colors in printing machines and offers photocell printing opportunity up to 3 colors on the backside of the material to be pressed. Besides, cold seal and lacquering applications can be realized "in-line". Among printing materials; 9-60 micron thickness aluminum foils, gravure

printable polymer films, papers, cardboard, laminated materials can be given as example.

With lamination machines, solvented lamination, solvent-free lamination and wet lamination processes can be conducted with "web inspection" systems using aluminum foil/polymer films, aluminum foil/papers, polymer films/polymer films in the form of 2-3 and 4 folded styles in accordance with the material to be used.

With aluminum foils of 9-250 microns and laminated materials, processes such as primer lacquering, thermo-lacquering and epoxy lacquering, wax coating and wax lamination can be conducted with wax machines. In single-layer and multi-layer structures, it is possible to measure coating weight during manufacturing thanks to "web coating weight measurement" system inline.

New extruder machine purchased in 2013 enabled us to conduct production of insulation, fridge rear foil, pe-lamination multi-layer structures. New label cutting machine will ensure the growth of our market share in food, beverage, cosmetics and pet food sectors.

İSPAK Inc. maintains its paths with its slogan of "continuous change" without compromising its principles and quality policy thanks to its valuable knowledge, systematic working principles and dynamic, innovative personnel focused on quality.

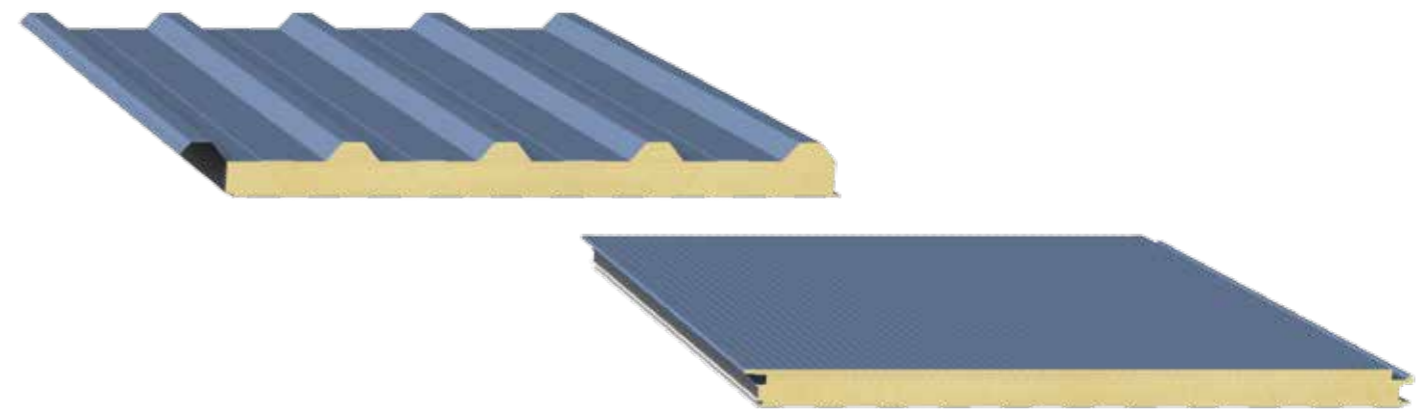
Kibar Industry Company

Kibar Industry Company operates in Jordan as the first overseas investment of Kibar Holding Group outside Turkey. Project studies started in Al Mafraq province located 45 km away from Amman in 2011, and production started as of the end of 2012. Established on 10,000 sqm covered/25,000 sqm open space, the company is the biggest sandwich panel factory in the Middle East with its production capacity of 4.5 million square meter using fully automatic production line and latest technologies.

Kibar Industry Company offers high quality structure and insulation material mainly to Iraq, Syria, Gulf countries and Egypt, Middle East and East Africa countries, and the company aims at becoming the market leader in its region. Sandwich panel is used as insulation and construction material for roof, facade, interior of building and air rooms. Manufactured

in desired quality and thickness of polyurethane between painted galvanized plates, these products ensure perfect heat, water and sound insulation. Preventing condensation of moisture in roof constructions and with high carrying capacity providing important engineering advantages, these panels come to the fore in architectural choices with their various shapes and color designs. Together with their price-performance qualities since they are easy to install and have economic advantages, they are used more and more than other alternative products.

In the plant, it is possible to conduct manufacturing of polyurethane/polyisocyanurate insulated roof and facade sandwich panels that offer high fire resistance, and 20 cm thick sandwich panels for cold storages. Rock wool sandwich panel production is the next stage in our investment plans.
