Founded by Kibar Holding in 1998, Assan Foods started its operations with its modern infrastructure and high-tech machinery in Susurluk, located near the Karacabey Plain, the leading region for industrial tomatoes used for the production of tomato paste. Assan Foods entered the sector by processing tomatoes and producing tomato paste and added ketchup to its portfolio in 2000, mayonnaise and sauces in 2002.

Assan Foods manufactures more than 300 products, including high-quality tomato and pepper paste, ketchup, mayonnaise, and various sauces in its production facilities in Susurluk and the Aegean Free Zone.

The Susurluk Plant of Assan Foods has one of the highest tomato processing capacities in a single location in Turkey. Built on a land of 200,000 sq. meters, the plant's covered area is 21,600 sq. meters; including the production facility and the warehouse, as well as management and service buildings and social facilities. The factory has the capacity to process 4,500 tons of fresh tomatoes and manufacture more than 2.5 million products on a day. In addition to its industrial investment of over 57 million USD, new investments continue rapidly. Located in the Aegean Free Zone, the Ege Assan Plant covers an area of 4,500 sq. meters and has an annual tomato paste packaging capacity of 24,000 tons.

Implementing many projects for sustainable agriculture, Assan Foods collaborates with farmers and carefully conducts necessary inspections at all stages of tomato plantation and growth. As part of the Smart Farming Project, Assan Foods monitors the development of special tomato seedlings and collects important data through meteorology stations and sensors placed in the fields. The data offers guidance on field-soil selection and production processes for upcoming years as well.

Assan Hanil, one of Kibar Group's automotive companies was established in 1997 with the partnership of Seoyon E-Hwa which is the leading automotive supplier in South Korea, started production as an OEM Part Supplier in the automotive industry.

While Assan Hanil was suppliying parts only for Hyundai Assan in the early years of its establishment, it has become one of the most important suppliers of Ford Otosan as of 2005. In the upcoming years, Assan Hanil has added Isuzu, Honda, AGCO, Mercedes-Benz Turkey and Turkey's Automobile Initiative Group (TOGG) to its customer portfolio respectively. In addition, Assan Hanil is one of the main suppliers for M2 Light Commercial Vehicle (H350), which is a joint project between Karsan and Hyundai Motor Company (HMC).





In 2019, Assan Hanil started-up Aksaray Plant for producing for Mercedes-Benz Turkey and Gölcük Plant for producing Ford Otosan. With over one thousand specialized employees working in its plants covering a total area of 175 thousand m² in five different locations; three in Kocaeli, one in Bursa and one in Aksaray; the company performs automation based production activities with high technology.

Today, Assan Hanil is a supplier of driver and passenger seat as well as door panels, front and rear bumper, instrument panel, console, carpet, FEM Carrier, blow molding parts, headlining, glove box, and various interior and exterior plastic components. It was founded in 2011 as a joint venture between Kibar Holding, Pohang Iron and Steel Company (POSCO), and POSCO Daewoo. The initial investment cost of Posto Assan TST, which is the owner of the first and only stainless steel cold rolling facility in Turkey, was 350 million dollars. The company began production in 2013 with an annual production capacity of 300,000 tons. It aims to meet all the needs of its customers in the fastest way possible and achieve the highest level of customer satisfaction all the time by producing high quality stainless steel.







As a result of the inspection conducted by the EASA (European Aviation Safety Agency), it obtained an ADOA (Alternative Procedures to Design Organisation Approval) in November 2012 and a POA (Production Organization Approval) in December 2013. It is authorized by the EASA and FAA (Federal Aviation Administration) to manufacture aircraft seats. According to the agreement signed in November 2019, TSI Seats is entitled to be included in Airbus' BFE (Buyer Furnished Equipment) catalog.

TSI continues to carry out its design, engineering, production, and R&D activities with its team of 130 people in its new facilities with a total area of 3,400 sq. meters and an annual seat manufacturing capacity of 36,000 pax at Istanbul Sabiha Gökçen Airport. Established by TSI for the aviation industry in the USA, TSI SEATS Inc. operates in Salt Lake City, Utah. TSI has completed the seat orders for 130 aircraft as of the end of 2019 and received firm orders for more than 200 aircraft to be delivered from 2020 to 2023.
