It serves a variety of sectors, including packaging, distribution, construction, durable consumer goods, automotive, and HVAC, with its coil, sheet, foil, and pre-painted aluminum products. Assan Alüminyum, operating under Kibar Holding at production facilities in Tuzla, Istanbul, and Dilovası, Kocaeli, is Türkiye's leading company in the flat-rolled aluminum industry, with an annual production capacity of up to 360,000 tons for sheet and foil, along with an annual aluminum painting capacity of 60,000 tons at its flat-rolled aluminum painting facilities. In addition, the company is one of the two largest aluminum foil manufacturers in Europe, with a production capacity of up to 130,000 tons. Assan Alüminyum was ranked 46th in the 2023 Türkiye's Top 500 Industrial Enterprises list of ISO.

In its early years, Assan Hanil supplied parts solely to Hyundai Assan. However, as of 2005, it became one of the key suppliers to Ford Otosan as well. In the following years, it successively added Isuzu, Honda, AGCO, Mercedes-Benz Türkiye, Türkiye's Automobile Joint Venture Group (TOGG), and Stellantis/Tofaş to its customer portfolio. Assan Hanil exports to South Korea the seats it has designed and manufactured at its Kocaeli facilities for Hyundai XCIENT Fuel Cell, the world's first hydrogen fuel cell-powered electric truck.

In 2019, the company commissioned its Aksaray plant to serve Mercedes-Benz Türkiye (MBT) and its Gölcük plant to serve Ford Otosan.

As a result, the company carries out manufacturing operations using automation-based advanced technology with over 1,400 specialized employees across five different locations—three in Kocaeli, one in Bursa, and one in Aksaray—covering a total area of 175,000 m².

Assan Hanil has certified the quality of its production with ISO 9001-2015, ISO 14001, ISO/IEC 27001-2013, ISO 45001 (OHSAS), IATF 16949-2016, ISO 31000 International Risk Management, Ford Q1, Hyundai 4-Star Quality System, and Daimler OSA Category-1 certificates. Assan Hanil, which has been conducting innovative projects focused on weight reduction, cost optimization,

In 2015, it reached a total production capacity of 18 million m²/year by successfully completing the investment for the second line at its Tuzla, Istanbul plant with a capacity of 3.5 million m²/year. In 2021, it made its first investment in the Turkic Republics, and the Azerbaijan Plant commenced operations in partnership with Sumqayıt Texnologiyalar Parkı (STP). Today, Assan Panel continues its operations as a leading manufacturer with a total production capacity of 22 million m²/year across its Tuzla, İskenderun, Balıkesir, Jordan, and Azerbaijan plants.

The carbon footprint has been minimized through the solvent recovery system installed at the factory, which was designed with environmental sensitivity in mind.

Technical foils used in HVAC products such as refrigerator back panels, air conditioning units, and heat pumps, as well as insulation materials, are manufactured at the Tuzla facility. In 2025, the new facility established next to the İzmit factory for the production, of technical foils is expected to reach a capacity of 10,000 tons.

As the first container terminal in İskenderun Bay to serve modern container ships, Assan Port İskenderun has become the second and a highly strategic alternative to Mersin in the same hinterland. With an annual installed capacity of 250,000 TEU, our terminal has increased its capacity to 400,000 TEU following the completion of the Land Terminal 1 investment. With ongoing investments in additional areas alongside the main terminal, Assan Port to increase its annual capacity to 650,000 TEU by 2025.
